Authority to Inspect

The Tusla Early Years Inspectorate carries out inspections of Early Years Services under Section 58(D) of the Child Care Act 1991 (as inserted by Section 92 of the Child and Family Agency Act 2013).

Description of Service	Crumlin Childcare Centre is a large full day care service located in an urban, residential area of Crumlin, South County Dublin. Care and education are provided to children aged 0-6 years and the service is currently registered to operate from Monday to Friday between 08:00 and 18:00 hours.
Premises	The service operates from a purpose-built premises in Crumlin, Dublin 12. Four care rooms are currently in operation in the service and a dedicated sleep room is available. Three outdoor play areas are available to the children to the front of the premises and in internal courtyards. This inspection assessed a fifth care room being added to the service which is located in a purpose-built modular building to the rear of the existing premises. The building consists of a large classroom and two separate sanitary areas, one for adults and one for children.
Staffing	The service currently employs twenty staff members, not including the registered provider who does not work directly in the service. The person in charge stated that three new staff will be employed in the service to work in the new care room.
Methodology	<p>The inspection was an announced inspection to assess compliance with the Childcare Act 1991 (Early Years Services) Regulations 2016 and Childcare Act 1991 (Early Years Services) (Amendment) Regulations 2016. The Inspection focused on regulations under the following themes: Governance, Health, Welfare and Development of the child, Safety and Premises.</p> <p>The findings on inspection based on information obtained through examination of documentation, direct observation, and discussion with relevant staff are documented in the inspection report and taken into consideration when making a decision in relation to registering the change in circumstance. Regulation 9 – Management and Recruitment

(1) A registered provider shall ensure that—

(a) the service has a designated person in charge and a named person who is able to deputise as required.

Part III - Management and Staff

Regulation 11 -Staffing Levels

(1) Subject to this Regulation, a registered provider shall ensure that there is at all times an adequate number of adults working directly with the children attending the pre-school service.

(8) Without prejudice to paragraphs (2) to (7)—

(b) a childminder shall ensure that a second person familiar with the operation of the service and in a position to provide assistance to the childminder in operating the service is, at all times, within close distance of the service and available to attend the service to assist the childminder in the event of an emergency, and

(c) a registered provider of a sessional pre-school shall ensure that, where the person in charge operates the service single-handedly, a second person familiar with the operation of the service and in a position to provide assistance to the person in charge in operating the service is, at all times, within close distance of the service and available to attend the service to assist the person in charge in the event of an emergency.

Requirement met:

The requirement has been met.

(1) The person in charge has identified that a minimum of two staff members will be on the premises at all times.

Part V - Care of Child in Pre-school Service

Regulation 20 - Facilities for Rest and Play

- (1) *Subject to this Regulation, a registered provider shall ensure that—*
- (a) *having regard to the number of pre-school children attending the service, their respective ages and the amount of time they spend on the premises, there are adequate and suitable facilities for each child to play indoors and, where required by these Regulations, outdoors, during the day, and*
 - (b) *there are adequate and suitable facilities for a pre-school child to rest during the day, and in the case of an overnight pre-school service, during the day and the night.*
- (2) *A registered provider—*
- (b) *of a full day care service, a part-time day care service, a sessional preschool service or a childminding service that moves premises on or after 30 June 2016, shall ensure that a suitable, safe and secure outdoor space to which the preschool children attending the service have access on a daily basis is provided on the premises.*
- (3) *A registered provider of a full day care service, a part-time day care service or a childminding service, other than such a service to which paragraph (2) applies, shall ensure that—*
- (a) *a suitable, safe and secure outdoor space to which the pre-school children attending the service have access on a daily basis is provided on the premises or*
 - (b) *where no such space is provided, the preschool children attending the service have access on a daily basis to an outdoor service*
- (4) *Where outdoor space to which the pre-school children attending the service have access is provided on the premises of a sessional pre-school service other than such a service to which paragraph (2) applies, a temporary pre-school service or a pre-school service in a drop-in centre, the registered provider shall ensure that such outdoor space is suitable, safe and secure.*
- (5) *Where pre-school children attending a sessional pre-school service other than such a service to which paragraph (2) applies, a temporary pre-school service or a pre-school service in a drop-in centre have access to an outdoor space other than such a space specified in paragraph 4, the registered provider shall ensure that such outdoor space is suitable.*

Requirement met:	<p>The requirement has been met.</p> <p>(1)(a) Adequate and suitable facilities were provided for children to play indoors and outdoors. The new classroom was bright and spacious and well laid out with various play materials on open, low level shelving units.</p> <p>(1)(b) Adequate and suitable rest facilities were available for preschool children to rest during the day in the room if required.</p> <p>(2)(a) The service has three designated, secure outdoor play areas on the grounds. The areas are fully enclosed, and a range of play materials are available in outdoor play spaces.</p> <p>(3)(a)(b) Not applicable.</p>

- (a) is safely stored in an easily accessible and conspicuous position on the premises, and
 - (b) is available to the children attending the pre-school service at all times.

Requirement met:

The requirement has been met.

(1) Certification was available to evidence that a person trained in first aid was available to the children at all times in the service.

(3) Suitably equipped first aid boxes were available in the service and stored in conspicuous locations.

Part VI – Safety

Regulation 26 – Fire Safety Measures

- (1) A registered provider shall ensure that a record in writing is kept of—
- (a) any fire drill that takes place in the premises, and
 - (b) the number, type and maintenance record of fire fighting equipment and smoke alarms in the premises.
- (4) A notice of the procedures to be followed in the event of fire shall be displayed in a conspicuous position in the premises.

The requirement has been met.

(a) The person in charge indicated that fire drills take place monthly in the service and appropriate documentation was in place to record them.

Part VI – Safety

Regulation 28 – Insurance

A registered provider shall ensure that the pre-school service is adequately insured.

Requirement met:

The requirement has been met.

Documentation reviewed evidenced that the service had adequate insurance in place for the proposed increase in children.

Part VII – Premises and Space Requirements

Regulation 29 – Premises

A registered provider shall ensure that the premises of the service are—

- (a) of sound and stable structure,*
- (b) safe and secure,*
- (c) kept adequately lit, heated and ventilated,*
- (d) cleaned, maintained and repaired, as required, and*
- (e) equipped with adequate and suitable sanitary facilities.*

Requirement met:

The requirement has been met.

(a) The care rooms are all purpose-built for use as a preschool service and appeared to be of sound and stable structure.

(b) The entrance and exit doors to the service and the new classroom were appropriately safe and secure on the day of inspection. The outdoor areas were secured to prevent a child exiting the area unsupervised and prevent unauthorised access.

(c) The new classroom benefited from natural light via openable windows which also provided adequate ventilation. There was an electric heating system in place

	<p>and thermostatically controlled radiators were in place to heat the care rooms when required.</p> <p>(d) Cleaning schedules were in place in the service. The premises and surrounding environments were clean and maintained as required.</p> <p>(e) The new classroom was equipped with adequate and suitable sanitary facilities. There were two toilets and two wash hand basins designated for use by the children. A separate bathroom was available for staff members. A nappy changing unit was available in the sanitary area should it be required. Thermostatically controlled hot and cold water was available in the hand wash sinks.</p>
