### Description of service

Grangemockler Community Playschool was established in 2006 and operates from a room within Grangemockler National School in Co Tipperary. A sessional and part-time service is provided for children aged 2 to 6 years from 9:00am to 1:30pm. The service has sole use of sanitary accommodation, located off the classroom and an enclosed outdoor area.

### Staffing

There is a total of four staff employed by the service. On the morning of inspection two staff were present. The designated person in charge was present on the day of inspection. The registered provider does not work directly in the service. Staff working directly in the service hold qualifications at level 5 and above on the National Framework of Qualifications, along with additional training in Leadership for Inclusion.

### Methodology

Tusla's Early Years Inspectorate is the independent statutory regulator of early years services in Ireland. The Child Care Act 1991 (Early Years Services) Regulations 2016 define the duty of a registered provider to ensure the safety and well-being of children and to comply with these regulations. This Act also gives Tusla the authority to assess compliance with the regulations. The purpose of regulation in relation to early years services is to ensure that the care, safety, and well-being of children attending such services is upheld. Inspections of early years services are planned based on the following:

- Previous inspection history
- Any information received in relation to the service

The findings on inspection are based on:

- Information obtained through examination of documentation
- Direct observation
- Discussion with relevant staff

This inspection was unannounced and focused on the area of governance/ health, welfare and development of child/ safety/ premises and facilities. The inspection may also focus on other areas as required.

Inspection findings are documented in the inspection report which is first issued in draft format to the service with an opportunity to respond to any findings. Where statutory requirements are identified as not being met, the registered provider must demonstrate how they have rectified the non-compliance and will prevent any non-compliance from re occurring. The Corrective Action and Preventive Action plan (CAPA) will be used to inform decisions about compliance with regulatory requirements. Where the registered provider fails to meet the statutory requirements an escalation process may be commenced.

The inspectorate reserves the right to edit responses received for reasons including clarity, completeness and compliance with administrative and legal processes.

## Part III – Management and Staff

### Regulation 9 – Management and recruitment

(1) *A registered provider shall ensure that-*

- (a) *the service has a designated person in charge and a named person who is able to deputise as required,*
- (b) *at all times during the period when the pre-school service is being carried on, the designated person in charge or the named person referred to in subparagraph (a) is on the premises, and*

(2) *A registered provider shall ensure that each employee, unpaid worker and contractor is suitable and competent taking into consideration the nature of the needs of children, including by-*

- (a) *consideration of references from the person's past employers, if any, and in particular the most recent employer, if any,*
- (b) *consideration of references from reputable sources in the case of a person who has no past employers,*
- (c) *consideration of the vetting disclosure received from the National Vetting Bureau of the Garda Síochána in accordance with the Act of 2012 in respect of the person, and*

*(d) ensuring, insofar as is practicable, that where a person has lived in a state other than the State for a period of longer than 6 consecutive months, he or she provides police vetting from the police authorities in that state.*

*(4) A registered provider shall ensure that, without prejudice to the generality of paragraph (2) and subject to paragraphs (5) and (6), each employee working directly with children attending the service holds at least a major award in Early childhood Care and Education at Level 5 on the National Qualifications Framework or a qualification deemed by the Minister to be equivalent.*

### Compliance Information

(1)(a) There was a designated person in charge and a named deputy designated person in charge who was able to deputise, as required.

(b) The designated person in charge was present for the inspection.

The staff files for four staff were reviewed on the day.

(2)(a) Two written and validated references were available for each staff member working at the service.

(b) Where past employer references were not available, there were references from sources such as previous schools and colleges.

(c) Garda vetting was available on file for each staff member working in the service. Garda vetting had been renewed, in compliance with the Early Years Inspectorate Regulatory Notice, requiring services to renew Garda vetting every three years.

(d) Not applicable. Review of the curriculum vitae indicated that police vetting was not required.

(4) Certificates of qualifications for the staff working directly with children were available on file demonstrating that they held a qualification at the minimum level 5 and above on the National Framework of Qualifications.

### Part III – Management and Staff

#### Regulation 11 - Staffing levels

*(1) Subject to this Regulation, a registered provider shall ensure that there is at all times an adequate number of adults working directly with the children attending the pre-school service.*

*(2) Subject to paragraphs (4) and (5), a registered provider of a full day care service or a part-time day care service shall ensure that at all times the minimum ratio of adults to children specified in column (3) of Part 1 of Schedule 6 opposite a particular reference number specified in column (1) of that Part in respect of the age range of the children specified in column (2) thereof at that reference number is satisfied.*

### Compliance Information

- (1) There were adequate staffing levels to respond to the children's needs on the day of inspection.
- (2) The adult child ratios during the day of inspection were above the minimum regulatory requirements. There were 2 staff caring for 12 children.

### Part IV – Information and Records

#### Regulation 15 – Record of pre-school child

- (1) A registered provider of a pre-school service other than a pre-school service in a drop-in centre or a temporary pre-school service shall ensure that a record in writing is kept in respect of each pre-school child attending the service containing the following particulars:
- (a) the name and date of birth of the child;
  - (b) the date on which the child first attended the service;
  - (c) the date on which the child ceased to attend the service;
  - (d) the name and address of a parent or guardian of the child and a telephone number where that parent or guardian or a relative or friend of the child can be contacted during the hours of operation of the service;
  - (e) authorisation for the collection of the child;
  - (f) details of any illness, disability, allergy or special need of the child, together with all the information relevant to the provision of special care or attention;
  - (g) the name and telephone number of the child's registered medical practitioner;
  - (h) record of immunisations, if any, received by the child;
  - (i) written parental consent for appropriate medical treatment of the child in the event of an emergency.
- (3) A record in writing referred to in paragraph (1) or (2) shall be open to inspection on the premises by-
- (a) a parent or guardian of a pre-school child but only in respect of the record relating to that child,
  - (b) an employee who is authorised in that behalf by the registered provider, and
  - (c) an authorised person.

### Compliance Information

A sample of 10 completed registration forms were reviewed as part of the inspection process:

- (1) The registration forms contained the required information as detailed under parts (a) to (i) of this regulation.
- (3) The registration forms were available on the premises for inspection by an authorised person.

### Part V - Care of Child in Pre-school Service

#### Regulation 21 – Equipment and materials

*A registered provider shall ensure that there is adequate and suitable furniture, play and work equipment and materials available on the premises of the pre-school service.*

#### Compliance Information

The service consisted of one large, bright pre-school room with sanitary accommodation. The room was well resourced and maintained with a wide range of toys, materials and furniture suitable to the age of the children attending the service. There were child sized tables and chairs for tabletop activities such as Montessori work, modelling clay, puzzles and eating at snack time. The rooms had several defined interest areas which included books, a dress up area, a construction area, home corner, a post office, sand pit and an area for messy play. There were low level open shelves around the room where arts and crafts material, jigsaws/puzzles and toys were easily accessible to the children. The walls were decorated with the children's artwork, colours, shapes and a visual timetable for the children. The outdoor area was to the rear of the school and was secure to prevent children leaving the service. There was access to ride on toys, tennis rackets, balls, hula hoops, cones and a painted roadway on the ground. There was a store of additional resources also available. Additionally, the service had access to a large grass area which was shared with the primary school.

### Part VI - Safety

#### Regulation 25 - First aid

*(1) A registered provider shall ensure that a person trained in first aid for children is, at all times, immediately available to the children attending the pre-school service.*

*(2) A registered provider shall ensure that a suitably equipped first aid box for children-*  
*(a) is safely stored in an easily accessible and conspicuous position on the premises, and*  
*(b) is available to the children attending the pre-school service at all times.*

#### Compliance Information

(1) There were staff trained in first aid responder (FAR) available to the children attending the service.  
(2)(a) There was a suitably equipped first aid box stored in an easily accessible position.  
(b) The first aid box was available to the children attending the service.

### Part VI - Safety

#### Regulation 26 - Fire safety measures

- (1) A registered provider shall ensure that a record in writing is kept of-*
- (a) any fire drill that takes place in the premises, and*
  - (b) the number, type and maintenance record of fire fighting equipment and smoke alarms in the premises.*
- (4) A notice of the procedures to be followed in the event of fire shall be displayed in a conspicuous position in the premises.*

#### Compliance Information

- (1)(a) There was a record of fire drills that had taken place in the service. The last fire drill was recorded as having taken place on the 12<sup>th</sup> of June 2025. The service was closed for July and August. Staff advised that monthly fire drills were completed.
- (b) There was a record available demonstrating that the smoke alarm system was last serviced in July 2025 and the firefighting equipment was last serviced in July 2025.
- (4) There was a notice of the procedures to be followed in the event of a fire displayed in a conspicuous position on the premises.

### Part VI - Safety

#### Regulation 28 - Insurance

*A registered provider shall ensure that the pre-school service is adequately insured.*

#### Compliance Information

An in-date insurance certificate was available for inspection to demonstrate that valid insurance was in place.
