Description of service

Boolavogue Play and Learn Playschool is a privately operated preschool service offering a play-based programme of care to children aged 2 to 6 years. The service operates from 8am to 6pm and offers a sessional service, part – time and can accommodate up to 33 children. The service is located within the local parish hall. The service consists of an entrance hall, one playroom, a kitchenette, children’s toilets, and storage space. Outside there is a secure garden and play area designated solely for the children.

Staffing

There are three staff working in the service. There is a designated person in charge daily. The registered provider works directly with the children attending the service. All staff working directly with children held the minimum level 5 and above qualifications in Childcare and Early Childhood Care and Education. A sixth staff member works in the kitchen.

Methodology

Tusla’s Early Years Inspectorate is the independent statutory regulator of early years services in Ireland. The Child Care Act 1991 (Early Years Services) Regulations 2016 define the duty of a registered provider to ensure the safety and well- being of children and to comply with these regulations. This Act also gives Tusla the authority to assess compliance with the regulations. The purpose of regulation in relation to early years services is to ensure that the care, safety, and well-being of children attending such services is upheld. Inspections of early years services are planned based on the following:

- Previous inspection history
- Any information received in relation to the service

The findings on inspection are based on:

- Information obtained through examination of documentation
- Direct observation
- Discussion with relevant staff

This inspection was unannounced and focused on the area of governance/ health, welfare and development of child/ safety/ premises and facilities. The inspection may also focus on other areas as required.

Regulation 19 - Health, Welfare and Development of the Child,
Regulation 23 - Safeguarding health, safety and welfare of child,

Inspection findings are documented in the inspection report which is first issued in draft format to the service with an opportunity to respond to any findings. Where statutory requirements are identified as not being met, the registered provider must demonstrate how they have rectified the non-compliance and will prevent any non-compliance from re occurring. The Corrective Action and Preventive Action plan (CAPA) will be used to inform decisions about compliance with regulatory requirements. Where the registered provider fails to meet the statutory requirements an escalation process may be commenced.

The inspectorate reserves the right to edit responses received for reasons including clarity, completeness and compliance with administrative and legal processes.

Part III – Management and Staff

Regulation 9 – Management and recruitment

(1) A registered provider shall ensure that-

- (a) the service has a designated person in charge and a named person who is able to deputise as required,
- (b) at all times during the period when the pre-school service is being carried on, the designated person in charge or the named person referred to in subparagraph (a) is on the premises, and

(2) A registered provider shall ensure that each employee, unpaid worker and contractor is suitable and competent taking into consideration the nature of the needs of children, including by-

- (a) consideration of references from the person's past employers, if any, and in particular the most recent employer, if any,
- (b) consideration of references from reputable sources in the case of a person who has no past employers,
- (c) consideration of the vetting disclosure received from the National Vetting Bureau of the Garda Síochána in accordance with the Act of 2012 in respect of the person, and
- (d) ensuring, insofar as is practicable, that where a person has lived in a state other than the State for a period of longer than 6 consecutive months, he or she provides police vetting from the police authorities in that state.

(4) A registered provider shall ensure that, without prejudice to the generality of paragraph (2) and subject to paragraphs (5) and (6), each employee working directly with children attending the service holds at least a major award in Early childhood Care and Education at Level 5 on the National Qualifications Framework or a qualification deemed by the Minister to be equivalent.

Compliance Information

(1)(a)(b)

There was a designated person in charge of the service on the inspector's arrival. There was a second named staff member available to deputise as needed.

The files for all staff working in the service were reviewed on the day.

(2)(a)(b)

There were validated references for each of the employees kept in each staff member's file.

(c)

Garda vetting disclosures were available for all staff working in the service. The service also demonstrated partial compliance with the Early Years Inspectorate Regulatory Notice requiring services to re-new Garda vetting every 3 years. See Regulation 23.

(d)

Police vetting disclosures were not required as no staff member had lived outside of the state for a period of longer than six months as an adult.

(4)
There were certificates of qualification for all staff members working directly with the preschool children available on file.

Part III – Management and Staff

Regulation 11 - Staffing levels

(1) Subject to this Regulation, a registered provider shall ensure that there is at all times an adequate number of adults working directly with the children attending the pre-school service.

(2) Subject to paragraphs (4) and (5), a registered provider of a full day care service or a part-time day care service shall ensure that at all times the minimum ratio of adults to children specified in column (3) of Part 1 of Schedule 6 opposite a particular reference number specified in column (1) of that Part in respect of the age range of the children specified in column (2) thereof at that reference number is satisfied.

Compliance Information

(1)(2)
During the inspection, there were an adequate number of staff working directly with the children.
During the morning, there were 2 staff caring for 15 children.
During the afternoon, there were 3 staff caring for 6 children.

Part V - Care of Child in Pre-school Service

Regulation 19 - Health, welfare and development of child

(1) A registered provider shall, in providing a pre-school service, ensure that-

(a) each child's learning, development and well-being is facilitated within the daily life of the pre-school service through the provision of the appropriate activities, interaction, materials and equipment, having regard to the age and stage of development of the child, and

Compliance Information

The following observations and discussions with staff reflected the children's experience within the service on the day of inspection:

(1)(a)
The children were playing in smaller groups on the inspector's arrival and were engaged in a variety of play and activities. Children were enjoying decorating gingerbread men decorations as part of their Christmas art and craft activities. The staff used a whiteboard for planning activities and themes for the month.

The children had their snacks in their playroom, and the mealtimes were relaxed and social. Parents supplied the food for the children's mealtimes, and these were stored in the fridge. The staff helped the children with opening their lunches and they talked about the plans for after snack. The children had access to their water drinks throughout the day, as they were freely accessible on a low table. A second snack was available to the children who attended for part time care.

The staff set up activities for the children to play with throughout the morning. These included gluing, homemade cement, painting, cutting, and the children choose what they wanted to engage with. The staff interactions with the children across the rooms were respectful, kind and positive with the staff observed checking in with the children at points during the day. Simple rules were used with the children to reinforce positive behaviours such as taking turns and asking children if they would like to join in group activities.

Parents spoke to staff during drop off and collection times, providing an opportunity for staff to share information with parents. The entrance hall was warm and welcoming with an information board displaying relevant information for parents.

The service consisted of a large hall which was sub divided into two playrooms, all with easy access to the outdoor play area and toilets. The playrooms were equipped with a wide variety of play materials and well-developed interest areas, which were suitable for the age and stage of development of the children using them. There were materials and toys such as dolls house, a shop, kitchen/home corner, blocks, magnetic toys, puzzles and jigsaws. Low open shelves allowed children to access materials independently during free play.

Children's identity and belonging was fostered through the display of their works of art and their recent learning, birthday walls, local community map, family photographs and individual hooks for their coats and bags.

Nappy changing took place as needed throughout the day and children who were toilet trained were encouraged to use the toilet independently. Staff prompted children with handwashing.

The outdoor area consisted of an enclosed area to the rear of the hall. The area had sufficient space with concreted area for ride on toys, a playhouse, and a messy area with sand pits and digging areas.

Part VI - Safety

Regulation 23 - Safeguarding health, safety and welfare of child

A registered provider shall ensure that all reasonable measures are taken to safeguard the health, safety and welfare of a pre-school child attending the service and that the environment of the service is safe.

Non-Compliance Information

General Safety:

The service did not demonstrate compliance with the Early Years Inspectorate Regulatory Notice requiring services to re-new Garda vetting every 3 years. There were Garda vetting disclosures on file for all staff members, however the vetting disclosure for one staff member was not dated within the previous 3 years in adherence to with the Early Years Inspectorate Regulatory Notice EYI-RN12.3 Renewal of Garda vetting.

Action submitted by the Registered Provider

The following response was submitted by the registered provider:

Corrective & Preventive Action:

Garda vetting was applied for immediately in respect of the one staff member.

We will ensure going forward that all staff have their vetting renewed within the timeframe.

Summary Comment

Part VI - Safety

Regulation 25 - First aid

(1) A registered provider shall ensure that a person trained in first aid for children is, at all times, immediately available to the children attending the pre-school service.

(2) A registered provider shall ensure that a suitably equipped first aid box for children-

(a) is safely stored in an easily accessible and conspicuous position on the premises, and

(b) is available to the children attending the pre-school service at all times.

Compliance Information

(1)
There was a person trained in a first aid responder course immediately available to the children attending the preschool service. There was evidence available to show four staff working directly with children were trained in a first aid responder course.

(2)(a)(b)
There was a suitably equipped first aid boxes stored in an easily accessible position on the premises which were available to the children attending the preschool service.

Part VI - Safety

Regulation 26 - Fire safety measures

(1) A registered provider shall ensure that a record in writing is kept of-

(a) any fire drill that takes place in the premises, and

(b) the number, type and maintenance record of firefighting equipment and smoke alarms in the premises.

(4) A notice of the procedures to be followed in the event of fire shall be displayed in a conspicuous position in the premises.

Compliance Information

(1)(a)
Fire drills were completed monthly. The last fire drill completed was recorded on the 4 November 2025.

(b)
A record was maintained when the firefighting equipment and smoke alarm system were serviced in May 2025.

(4)

There was a notice of the procedures to be followed in the event of fire displayed in a conspicuous position in the hallway of the service.

Part VI - Safety

Regulation 28 - Insurance

A registered provider shall ensure that the pre-school service is adequately insured.

Compliance Information

The registered provider had a valid certificate of insurance for 33 children.
