Description of service

Scoil na nÓg Naíonra is a privately-operated sessional preschool service. The service operates from 8.45am to 11.15pm, Monday to Friday. The service caters for 22 preschool children aged from 2 to 6 years. The aim of the service “is to meet the needs of children in a fun, playful learning environment which promotes the use of the Irish language.”

Staffing

There are two staff employed to work in the service. The registered provider is the designated person in charge and works directly with the children attending the service. All the staff working in the service held the minimum level 5 and above qualifications in Childcare and Early Childhood Care and Education. The service has a third adult available to work as a relief person if needed.

Methodology

Tusla’s Early Years Inspectorate is the independent statutory regulator of early years services in Ireland. The Child Care Act 1991 (Early Years Services) Regulations 2016 define the duty of a registered provider to ensure the safety and well-being of children and to comply with these regulations. This Act also gives Tusla the authority to assess compliance with the regulations. The purpose of regulation in relation to early years services is to ensure that the care, safety, and well-being of children attending such services is upheld. Inspections of early years services are planned based on the following:

- Previous inspection history
- Any information received in relation to the service

The findings on inspection are based on:

- Information obtained through examination of documentation
- Direct observation
- Discussion with relevant staff

This inspection was unannounced and focused on the area of governance/ health, welfare and development of child/ safety/ premises and facilities. The inspection may also focus on other areas as required.

Part III – Management and Staff

Regulation 9 – Management and recruitment

(1) A registered provider shall ensure that-

- (a) the service has a designated person in charge and a named person who is able to deputise as required,
- (b) at all times during the period when the pre-school service is being carried on, the designated person in charge or the named person referred to in subparagraph (a) is on the premises, and

(2) A registered provider shall ensure that each employee, unpaid worker and contractor is suitable and competent taking into consideration the nature of the needs of children, including by-

- (a) consideration of references from the person's past employers, if any, and in particular the most recent employer, if any,
- (b) consideration of references from reputable sources in the case of a person who has no past employers,
- (c) consideration of the vetting disclosure received from the National Vetting Bureau of the Garda Síochána in accordance with the Act of 2012 in respect of the person, and
- (d) ensuring, insofar as is practicable, that where a person has lived in a state other than the State for a period of longer than 6 consecutive months, he or she provides police vetting from the police authorities in that state.

(4) A registered provider shall ensure that, without prejudice to the generality of paragraph (2) and subject to paragraphs (5) and (6), each employee working directly with children attending the service holds at least a major award in Early childhood Care and Education at Level 5 on the National Qualifications Framework or a qualification deemed by the Minister to be equivalent.

Compliance Information

(1)(a)(b)

The registered provider was the designated person in charge of the service on the inspector's arrival. There was a second named staff member available to deputise as needed.

The files for all staff working in the service were reviewed on the day, including the relief staff.

(2)(a)(b)

There were validated references for each of the employees kept in each staff member's file.

(c)

Garda vetting disclosures were available for all staff working in the service. The service also demonstrated compliance with the Early Years Inspectorate Regulatory Notice requiring services to re-new Garda vetting every 3 years.

(d)

Police vetting disclosures were not required as none of staff had lived outside of the state for a period of longer than six months as an adult.

(4)

There were certificates of qualification for the staff members working directly with the children available on file.

Part III – Management and Staff

Regulation 11 - Staffing levels

(1) Subject to this Regulation, a registered provider shall ensure that there is at all times an adequate number of adults working directly with the children attending the pre-school service.

(3) Subject to paragraph (5), a registered provider of a sessional pre-school service shall ensure that at all times the minimum ratio of adults to children specified in column (3) of Part 2 of Schedule 6 opposite a particular reference number specified in column (1) of that Part in respect of the age range of the children specified in column (2) therefore at that reference number is satisfied.

Compliance Information

(1)(3)

During the inspection, there were an adequate number of staff working directly with the children.

There were 18 children in the care of 2 staff.

Part V - Care of Child in Pre-school Service

Regulation 20 – Facilities for rest and play

(1) Subject to this regulation, a registered provider shall ensure that-

- (a) having regard to the number of pre-school children attending the service, their respective ages and the amount of time they spend on the premises, there are adequate and suitable facilities for each child to play indoors and, where required by these Regulations, outdoors, during the day, and
- (b) there are adequate and suitable facilities for a pre-school child to rest during the day, and in the case of an overnight pre-school service, during the day and the night.

Compliance Information

(1)(a)

All of the children attending the service on the day of inspection had access to both indoor and outdoor spaces for play.

The service was located in the Gaelscoil and consists of one large room, with a separate entrance and toilets. The playroom was bright and warm with sufficient space for the number of children attending. The room was furnished to meet the needs of the age and stage of development of the children using them.

Children had access to their own designated garden and play area located to the side of the premises. The outside area and garden were fully enclosed and was well developed and resourced with a variety of toys, equipment and interest areas for the children to use. The areas included digging and planting sections, picnic benches, chalk boards and a mud kitchen. The children enjoyed time outside before their morning snack. They were well supervised on the transition back into the playroom.

(b)

The room had a quiet area in the corner for children to sit and relax. It had a small soft sofa that were used by the children daily. The area also had soft cushions and reading materials. The children could rest and relax on the sofa as and when they want.

Part V - Care of Child in Pre-school Service

Regulation 21 – Equipment and materials

A registered provider shall ensure that there is adequate and suitable furniture, play and work equipment and materials available on the premises of the pre-school service.

Compliance Information

The playroom was bright and warm with natural light and ventilation from openable windows. The room had low shelving with trays and boxes of toys including materials and toys which were easily accessible to the children. The tables and chairs were suitable to the ages of the children using them.

Throughout the rooms the interest areas were well-resourced, and included a home corner, construction toys, dress up clothes, puzzles, art and craft materials, bricks and reading books. The children were observed fully engaged in their play and learning during the inspector's visit. The interactions between the children and staff were kind and gentle, and the staff were familiar with the individual children's likes, dislikes and personalities. Throughout the rooms children's artwork was displayed along with photographs of their families, birthdays, and their daily routine. The atmosphere throughout the morning was calm and relaxed, with the transitions between activities calm.

Part V - Care of Child in Pre-school Service

Regulation 22 – Food and drink

A registered provider shall ensure that adequate and suitable, nutritious and varied food and drink is available for each pre-school child attending the pre-school service.

Compliance Information

The service had a healthy eating policy, and parents were asked to supply the mid-morning snack. The children's snacks were stored in the fridge in the room. Children had access to their drinks throughout the morning. On the day of inspection children ate a variety of snacks which included fruit, yogurt, crackers and sandwiches. Children were supervised with handwashing before they ate.

Part VI - Safety

Regulation 25 - First aid

(1) A registered provider shall ensure that a person trained in first aid for children is, at all times, immediately available to the children attending the pre-school service.

(2) A registered provider shall ensure that a suitably equipped first aid box for children-

(a) is safely stored in an easily accessible and conspicuous position on the premises, and

(b) is available to the children attending the pre-school service at all times.

Compliance Information

(1)

There was a person trained in a first aid responder (FAR) course immediately available to the children attending the service. There was evidence on file that showed two staff working directly with children were trained in first aid responders.

(2)(a)(b)

There was a suitably equipped first aid boxes stored in an easily accessible position on the premises which were available to the children attending the preschool service.

Part VI - Safety

Regulation 26 - Fire safety measures

(1) A registered provider shall ensure that a record in writing is kept of-

(a) any fire drill that takes place in the premises, and

(b) the number, type and maintenance record of firefighting equipment and smoke alarms in the premises.

(4) A notice of the procedures to be followed in the event of fire shall be displayed in a conspicuous position in the premises.

Compliance Information

(1)(a)

Fire drills were completed monthly. The last fire drill completed was recorded on the 03 March 2026.

(b)

A record was maintained when the firefighting equipment and smoke alarm system were serviced in November 2025.

(4)

There was a notice of the procedures to be followed in the event of fire displayed in a conspicuous position in the service.

Part VI - Safety

Regulation 28 - Insurance

A registered provider shall ensure that the pre-school service is adequately insured.

Compliance Information

The service had a valid certificate of insurance for a sessional service for 22 children.
